Joined our team in 2016. Responsible for the office and administration, including control and exchange of documents with providers, clients and accountants. In charge of the company's payment cycle.

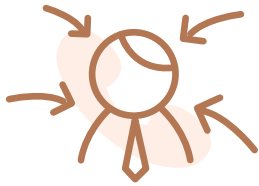

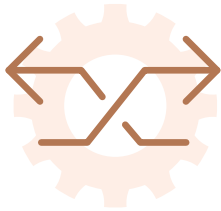

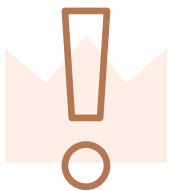
